



**Request for Exemption to the First Year Mandatory Housing Requirement**

All first-year students are required to live on campus unless they meet one or more criteria to be exempt from the residency requirement. Students must complete this form to apply for exemption. I would like to request an exemption from the mandatory first-year student housing requirement for the following reason (check one):

- I am 21 years of age or older. **Required documentation:** Proof of age (birth certificate or copy of passport).
- I reside with my parent(s) or legal guardian(s) full-time in their primary residence and located within the 35-mile commuting distance of the University. **Required documentation:** Must provide one of the following: a copy of a current utility bill, lease or mortgage, or a copy of a recent tax return (Social Security Number and income may be blocked out). Documentation must verify student physically resides with parent(s) or legal guardian(s). *\*Students requesting an exemption due to residency with parent(s) or legal guardian(s) within a 35-mile radius must also obtain the signature of a notary public. The form must be notarized with signatures from the student, a parent or legal guardian.*
- Married. **Required documentation:** Copy of marriage license.
- I have a dependent who lives with me. **Required documentation:** Copy of birth certificate(s) or a copy of your Federal Income Tax return showing exemptions claimed for dependent(s).
- I am a part-time student (less than 12 credit hours a semester).
- Active-duty military status. **Required documentation:** Copy of military orders or letter from current command.
- Financial hardship. **Required documentation:** Attach a typed, written explanation supporting a hardship exemption (parent's recent job loss, loss of financial aid, significant out-of-pocket expense to cover the costs to live on campus. Student is required to have completed the FAFSA and have spoken with a Financial Aid counselor to discuss various options prior to submitting an exemption request based on financial hardship).
