Please enroll the student named above in the Out-of-State Guaranteed Undergraduate Tuition Rate Program.

By initialing and signing below I understand and agree to the following terms, conditions and requirements of participation in the Out-of-State Guaranteed Undergraduate Tuition Rate (OSGUTR) Program:

- The OSGUTR Program begins with the fall 2009 semester and ends at the close of the spring 2013 semester. Enrollment in fall 2009 semester is mandatory.
- The OSGUTR is available only to first time freshman.
- The \$100.00 enrollment fee must be paid by Friday August 28, 2009 in order to participate in the OSGUTR Program.
- The OSGUTR applies to all academic terms, including summer session.
- The OSGUTR applies to and includes rates for residential, satellite and online courses.
- All participants in the OSGUTR Program must remain in good academic standing as described and published in the current university catalog which can be found on the Norfolk State University website at [www.nsu.edu/catalog/UndergraduateCatalog.html](http://www.nsu.edu/catalog/UndergraduateCatalog.html)
- The OSGUTR is only available to out-of-state students and international students.
- The OSGUTR covers **tuition only** and **DOES NOT** include fees, room, board or books.
- The OSGUTR does not apply to graduate students.

- The OSGUTR is guaranteed\* (locked-in) for four (4) years only. Students who do not complete their studies in the four (4) year period indicated above will be responsible for paying the then-published out-of-state tuition rate for any additional coursework undertaken beyond that four (4) year period.

*\*Per Virginia law, the tuition and fee charges to nonresident (out-of-state) students shall not be less than 100 percent of the average cost of education as calculated by the State Council of Higher Education (SCHEV) in consultation with the Virginia Department of Planning and Budget. If the OSGUTR fails to meet this requirement, the OSGUTR will be raised to comply with the law. Per Virginia law, the tuition rate for nonresident (out-of-state) students may not be lower than the rate charged to in-state students. If the OSGUTR becomes lower than the tuition rate charged to in-state students at any time during the 4 year lock-in period, the OSGUTR will be adjusted to comply with the law.*
