Dr. Messaoud Bahoura, Professor of Engineering and Director of the Center for Materials Research (I), received the 2025 Outstanding Faculty Award from the State Council of Higher Education and Dominion Energy.

In summarizing Dr. Bahoura's accomplishments, the SCHEV award website states, "Dr. Messaoud Bahoura is a distinguished Professor of Engineering and Director of the Center for Materials Research at Norfolk State University (NSU). With over 20 years of leadership in


cutting-edge research, he has spearheaded pioneering projects in renewable energy and advanced nanomaterials. Dr. Bahoura secured \$36 million in funding, the largest in NSU's history, and mentored the highest number of STEM doctoral graduates at the institution. He has authored over 100 peer-reviewed publications and presented at 177+ global conferences. His impactful STEM outreach initiatives have empowered underrepresented youth in the community. In recognition of his exceptional contributions, Dr. Bahoura received NSU's highest honors: the University Professor Award and the Distinguished Scholarship Award in 2024. He holds a B.S. in Physics from USTHB, Algeria, and an M.S. and Ph.D. degrees in Physics from Paris-Sud University, France."



Brown-Meredith, E. organized a mental health event in collaboration with the NSU Counseling Center, "Say it Out Loud," on March 11. The event included an interactive presentation and conversation on mental health for NSU students.

Tetteh, A. was invited to and presented at Union County Delta Sigma Theta Women's Conference. The conference theme was "Increasing Financial Awareness."

Alston, S. organized a "Black Girls in Stem Workshop" with a subaward from the National Science Foundation, a four-day workshop for up to 30 girls in middle and high school. Participants visited the Paradise Creek Nature Center, Learning Barge, and the Ryan Resilience Lab and spent time with biology faculty from NSU and Hampton University, April 16-19.



Dr. Viola Vaughan-Eden was extremely honored to be invited to the UN Women Headquarters with colleagues Danielle Pollack, GW University National Family Violence Law Clinic and Katie Spearman, John Hopkins University PhD Nursing Candidate, to consult with the United Nations International Children's Emergency Fund Innocenti (UNICEF-Innocenti), the World Health Organization (WHO), the World Bank Group (WBG), and the Sexual Violence Research Initiative (SVRI) for an expert meeting to review the findings of a systematic review examining the scientific evidence on the impact of family court proceedings on the health and well-being of women and children in cases involving violence in the home. "What an amazing experience collaborating on upstream solutions with an international group of key stakeholders the findings, implications for policy and practice, and explored potential next

steps addressing Violence Against Women and Children," Dr. Vaughan-Eden said.



Dr. Isiah Marshall Jr., Dean and Professor of the Ethelyn R. Strong School of Social Work, represented the International Federation of Social Workers in North America (IFSW) and the National Association of Social Workers (NASW) for the annual Social Work Day at the United Nations. The meeting focuses on exposing students to the critical role that social workers play in supporting populations impacted by global social issues. Dr. Marshall was selected to attend this meeting by current NASW President, Dr. Yvonne Chase, who is a graduate of the social work doctoral program at NSU. Dr. Marshall also participated in a faculty roundtable discussion held at Fordham University where he argued the need for more students from HBCUs to consider international careers with organizations such as the UN, UNICEF, and World Bank. Norfolk State University was the

only HBCU represented at both events on Friday, April 4th. Next year, Dr. Marshall plans to select two social work students to attend this event in New York City.

In Fall 2024, **Dr. Williamson-Ashe**, Professor of Social Work, received the **Certified Social Work Manager** credential from the Network for Social Work Management. The CSWM™ credential is a mark of excellence for social work managers who have demonstrated the highest levels of competence and dedication to the profession. By earning the CSWM™ credential, professionals demonstrate their commitment to advancing their leadership skills and knowledge, as well as their ability to effectively manage the complex challenges facing social work/human service organizations today. To earn the CSWM™ credential, candidates must meet rigorous eligibility requirements, including a combination of education, experience, and professional development.

In Spring 2025, **Dr. Williamson-Ashe** has been recognized as by the Future World Changers in the Academy (FWCA) as a **2025 Distinguished Nominee** for the **Zenobia L. Hikes Award.** The **Zenobia Lawrence Hikes Award** from Virginia Tech University recognizes a woman of color with a distinguished career (more than 15 years) in higher education demonstrated by scholarly endeavors or administrative and professional accomplishments. Additionally, she is an engaged member of her campus and community, with a history of advancing the development of women of color as they pursue their education and prepare for careers in the academy and beyond.
