MINUTES

1. Call to Order

Dr. Byron L. Cherry, Rector, called the Executive Committee meeting to order at approximately 10:37 a.m. A quorum of the Committee was established by Roll Call vote.

2. Approval of Minutes

Dr. Adams motioned, seconded by Mr. Crowder and with a 4-0 Roll Call vote approved the December 7, 2017 Executive Committee minutes.

3. Discussion Items

Dominion Deed of Easement Right of Way – Mr. Kashiri stated that the easement request is to provide power for the housing complex construction site. The residential life complex is on an expedited schedule so the approval is needed to grant the access as soon as possible for the university to meet the construction deadline of July 2019.

Mr. Forehand stated that the Deed of Easement has been approved for legal sufficiency.

Dr. Adams motioned, seconded by Mr. Crowder and with a 4-0 Roll Call vote approved that the Executive Committee approve, on behalf of the Board of Visitors, the Deed of Easement for Right of Way granting Dominion Power an easement over certain property of the university under the terms stated in the Deed of Easement, which Deed of Easement is to be included in the minutes of this meeting; and further moved that the Rector be authorized to execute the Deed of Easement on behalf of the Board of Visitors.

Master Equipment Leasing Program (MELP) – Synthetic Turf & Cushioning System with Storm Drainage System – Mr. Hunter stated that this request is to set up financing for the turf project that is currently underway in Dick Price Stadium. Using a cash flow strategy, it is in the university's best interest to use term financing rather than the cash available through the Auxiliary Fund balance.

Mr. Hunter, Dr. Stith and Mr. Miller spoke about the benefits and opportunities of the artificial turf installation (also see handouts provided). The installation will generate revenue for the university as a practice field, host for high school football games for Norfolk Public Schools, special arena and Junior Olympic events. The annual maintenance cost of the grass surface is approximately \$200,000. The total cost for the artificial turf is estimated at \$1.6M. The university can request financing for approximately \$1.2M of the total cost for equipment and materials. The labor cost is excluded, which cannot be financed. The Controller's recommendation is to seek the five-year option at approximately 1.5%.

In response to Dr. Adams, Mr. Hunter stated that there may be minor maintenance associated with the turf for painting or a tear.

In response to Mr. Crowder, Ms. Amaya Gordon stated that the university is still in compliance with its debt ratio with this request.

An updated resolution was provided to the Executive Committee. For clarity, Ms. Boston stated that through her review, wording was added as to the reason why this action is needed and that the action is to approve term financing with the Department of the Treasury.

Mr. Crowder motioned, seconded by Mr. Henry and with a 4-0 Roll Call vote approved that the Executive Committee approve, on behalf of the Board of Visitors, that the university enter into term financing under the Department of Treasury's Master Equipment Leasing Program (MELP) for the Synthetic Turf & Cushioning System with Storm Drainage System.

Amendment to the Affiliation Agreements between the University and Three Foundations – Mr. Forehand stated that one of the items on the SACSCOC agenda is to examine the relationship between the university and its affiliated foundations. In his discussions with Dr. Marty Sharpe, who is working on the SACSCOC accreditation submission, it was determined that it would be important to provide something in writing to show that the university is actively engaged with the three affiliated foundations as the agreements are dated. Also, since the execution of the agreements, the university has passed BOV Policy #13 University-Related Foundations that governs the relationship between the parties.

Mr. Forehand stated that instead of going meticulously through each agreement in short order, the simplest action is the creation of an amendment to document that the affiliated foundations are in compliance with BOV Policy #13 and that they agree to all the terms in the policy. If there are conflicts in the agreements, the policy prevails. He has contacted the three foundations and Ms. Fran Steward with the Athletics Foundation has polled its members and they are on board. Mr. Hud Croasdale with NSURIF has not responded yet.

Mr. Kelvin Arthur with the NSUF, who was present, stated that members of the Board are currently looking at the addendum. The NSUF is in compliance with BOV Policy #13 and meets annually with the Board of Visitors through the BOV/NSUF Liaison Committee. The only minor concern is the intent of item (2.) as it is a broad statement. The amendment is a very efficient way to respond to the policy, as there have been several attempts to incorporate the policy into the MOU between the university and the foundation. He does not anticipate a problem with signing the amendment and is waiting on the approval from the NSUF.

Dr. Adams motioned, seconded by Mr. Crowder and with a 4-0 Roll Call vote approved that the Executive Committee approve, on behalf of the Board of Visitors, the three addendums to the agreements between the University and the Norfolk State University Foundation, the Norfolk State University Research and Innovation Foundation, and the Athletics Foundation of Norfolk State University, which addendums shall be included in the minutes of this meeting and that the Rector be authorized to make non-substantive changes to the form of the addendums as necessary; and further be authorized to executive the addendums on behalf of the Board of Visitors.

4. General Comments

SACSCOC – In response to Mr. Crowder, Dr. Stith stated that the SACSCOC Mock Visit in June went well. Suggestions were made to improve the document and those are being incorporated. The submission is due to SACSCOC before the September 14, 2018, Board of Visitors meeting but the Board will receive a copy of the draft.

In response to Dr. Cherry, Mr. Forehand stated that it might be perceived as overreaching if the Board wishes to make substantial changes to the SACSCOC accreditation report. The Board's comments/suggestions should be informal.

Move In – Dr. Stith stated that approximately 1,100 freshmen are expected for "Move In" day tomorrow. Academically, this may be one of the most gifted classes in recent history.

Listening Session – Mr. Crowder stated that there is a Presidential Search Committee Listening Session at noon today.

DEED OF EASEMENT FOR RIGHT OF WAY

THIS DEED OF EASEMENT FOR RIGHT OF WAY (also referred to as RIGHT OF WAY EASEMENT), is made and entered into as of this **End** day of **July**, 2018, by and between THE VISITORS OF NORFOLK STATE UNIVERSITY, a body corporate and an agency of the Commonwealth of Virginia ("GRANTOR") and VIRGINIA ELECTRIC AND POWER COMPANY, a Virginia public service corporation, doing business in Virginia as Dominion Energy Virginia, with its principal office in Richmond, Virginia ("GRANTEE").

WITNESSETH:

1. That for and in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged. And in accordance with VA Code § 23.1-1301 and 2.2-1151, GRANTOR grants unto GRANTEE, its successors and assigns, the perpetual right, privilege and non-exclusive easement over, under, through, upon and across the property described herein, for the purpose of transmitting and distributing electric power by one or more circuits; for its own internal telephone and other internal communication purposes directly related to or incidental to the generation, distribution, and transmission of electricity, including the wires and facilities of any other public service company in aid of or to effectuate such internal telephone or other internal communication purposes; and for lighting purposes; including but not limited to the right:

1.1 to lay, construct, operate and maintain one or more lines of underground conduits and cables including, without limitation, one or more lighting supports and lighting fixtures as **GRANTEE** may from time to time determine, and all wires, conduits, cables, transformers, transformer enclosures, concrete pads, manholes, handholes, connection boxes, accessories and appurtenances desirable in connection therewith; the width of said non-exclusive casement shall extend FIFTEEN (15) feet in width across the lands of **GRANTOR**; and

2. The easement granted herein shall extend across the lands of GRANTOR situated in NORFOLK, Virginia, as more fully described on Plat(s) Numbered 21-18-0042, attached to and made a part of this Right of Way Easement; the location of the boundaries of said easement being shown in broken lines on said Plat(s), reference being made thereto for a more particular description thereof.

3. All facilities constructed hereunder shall remain the property of **GRANTEE**. **GRANTEE** shall have the right to inspect, reconstruct, remove, repair, improve, relocate on the easement, and make such changes, alterations, substitutions, additions to or extensions of its facilities as **GRANTEE** may from time to time deem advisable.

4. GRANTEE shall have the right to keep the easement clear of all buildings, structures, trees, roots, undergrowth and other obstructions which would interfere with its exercise of the rights granted hereunder, including, without limitation, the right to trim, top, retrim, retop, cut and keep clear any trees or brush inside and outside the boundaries of the easement that may endanger the safe and proper operation of its facilities. All trees and limbs cut by GRANTEE shall remain the property of GRANTOR.

5. For the purpose of exercising the right granted herein, **GRANTEE** shall have the right of ingress to and egress from this casement over such private roads as may now or hereafter exist on the property of **GRANTOR**. The right, however, is reserved to **GRANTOR** to shift, relocate, close or abandon such

private roads at any time. If there are no public or private roads reasonably convenient to the easement, GRANTEE shall have such right of ingress and egress over the lands of GRANTOR adjacent to the easement. GRANTEE shall exercise such rights in such manner as shall occasion the least practicable damage and inconvenience to GRANTOR.

6. GRANTEE shall repair damage to roads, fences, or other improvements (a) inside the boundaries of the casement (subject, however, to GRANTEE's rights set forth in Paragraph 4 of this Right of Way Easement) and (b) outside the boundaries of the easement and shall repair or pay GRANTOR, at GRANTEE's option, for other damage done to GRANTOR's property inside the boundaries of the easement (subject, however, to GRANTEE's rights set forth in Paragraph 4 of this Right of Way Easement) and outside the boundaries of the easement caused by GRANTEE in the process of the construction, inspection, and maintenance of GRANTEE's facilities, or in the exercise of its right of ingress and egress; provided GRANTOR gives written notice thereof to GRANTEE within sixty (60) days after such damage occurs.

7. GRANTOR, its successors and assigns, may use the easement for any reasonable purpose not inconsistent with the rights hereby granted, provided such use does not interfere with GRANTEE's exercise of any of its rights hereunder. GRANTOR shall not have the right to construct any building, structure, or other above ground obstruction on the easement; provided, however, GRANTOR may construct on the easement fences, landscaping (subject, however, to GRANTEE's rights in Paragraph 4 of this Right of Way Easement), paving, sidewalks, curbing, gutters, street signs, and below ground obstructions as long as said fences, landscaping, paving, sidewalks, curbing, gutters, street signs, and below ground obstructions do not interfere with GRANTEE's exercise of any of its rights granted hereunder. In the event such use does interfere with GRANTEE's exercise of any of its rights granted hereunder, GRANTEE may, in its reasonable discretion, relocate such facilities as may be practicable to a new site designated by GRANTOR and acceptable to GRANTEE. In the event any such facilities are so relocated, GRANTOR shall reimburse GRANTEE for the cost thereof and convey to GRANTEE an equivalent easement at the new site.

8. GRANTEE's right to assign or transfer its rights, privileges and easements, as granted herein, shall be strictly limited to the assignment or transfer of such rights, privileges and easements to any business which lawfully assumes any or all of GRANTEE's obligations as a public service company or such other obligations as may be related to or incidental to GRANTEE's stated business purpose as a public service company; and any such business to which such rights, privileges and easements may be assigned shall be bound by all of the terms, conditions and restrictions set forth herein.

9. If there is an Exhibit A attached hereto, then the easement granted hereby shall additionally be subject to all terms and conditions contained therein provided said Exhibit A is executed by GRANTOR contemporaneously herewith and is recorded with and as a part of this Right of Way Easement.

10. Whenever the context of this Right of Way Easement so requires, the singular number shall mean the plural and the plural the singular.

11. GRANTEE agrees to indemnify, protect, defend and hold GRANTOR, its employees, students and agents, harmless from and against all claims, actions, losses, damages, costs, expenses and liabilities arising out of injury to or death of any person or loss of a or damage to any property in or upon the easement or GRANTOR'S contiguous area, including the person or property of GRANTOR, its employees, students, agents, licensees, or others, to the extent such injury, death, loss or damage is caused by acts or omissions of GRANTEE, its agents or employees. The foregoing indemnity shall not apply to

any claims, actions, losses, damages, costs, expenses and liabilities arising from any act or omission of GRANTOR, its agents, employees, students, licensees or others.

12. If **GRANTEE** at any time discontinues use of all or any portion of the easement herein conveyed for a period of one year, all of the **GRANTEE's** rights and interest in said easement or portion thereof shall immediately terminate and revert to **GRANTOR**, its successors and assigns, and **GRANTEE** shall at its expense remove any facilities and restore **GRANTOR's** property as nearly to its original condition as practicable and, on written request by **GRANTOR**, **GRANTEE** shall quitclaim and release same.

13. This easement of right-of-way, and the use thereof, is intended to be used solely for the benefit of the lands of **GRANTOR**. No other use shall be permitted without the express prior written consent of **GRANTOR**, which consent **GRANTOR** shall be under no obligation to give. Consent shall be evidenced by an amendment to this Deed of Easement for Right of Way, approved and executed with the same formality as this Deed of Easement for Right of Way, and shall be subject to all conditions therein set out. If this easement is used for the benefit of lands not owned by **GRANTOR** without the prior written consent of **GRANTOR**, **GRANTOR** shall have the right to terminate this easement on ninety (90) days' notice, during which period **GRANTEE** shall remove its personal property and equipment and restore the land disturbed by such activity or, if not removed, such personal property and equipment shall be deemed abandoned in place.



NORFOLK STATE UNIVERSITY BOARD OF VISITORS RESOLUTION TO APPROVE MASTER EQUIPMENT LEASE FINANCING

WHEREAS, Norfolk State University ("NSU") seeks to enter into term financing under the Department of Treasury's Master Equipment Leasing Program (MELP) for the purchase of a Synthetic Turf and Cushioning System with Underground Storm Drainage; and

WHEREAS, with the purchase of a new Synthetic Turf and Cushioning System with Underground Storm Drainage, the University will be in compliance with the Department of Environmental Quality regulations as it pertains to storm water runoff; and

WHEREAS, the synthetic turf field provides added safety to the student athletes in direct relation with injuries, reduces future field maintenance expenses for the University, and will help to support student activities and University events; and

WHEREAS, the financing terms of 5, 7, or 10 years are available and the estimated cost is to be \$1,200,895 for the materials and equipment; and

WHEREAS, William Dick Price Football Stadium was built in 1997 and the surface was natural grass which required extensive maintenance due to significant use over time; and

THEREFORE, BE IT RESOLVED, that after due consideration and careful review by the NSU Vice President of Finance and Administration, the University President, and the NSU Executive Committee, the Norfolk State University Board of Visitors' Executive Committee on behalf of the Norfolk State University Board of Visitors approves this resolution to enter into term financing under the Department of Treasury's Master Equipment Leasing Program (MELP) as presented this 10th day of August 2018 subject to best available terms.

ADDENDUM TO AGREEMENT

Whereas, the Norfolk State University Foundation ("the Foundation") and Norfolk State University ("the University") entered into a Memorandum of Understanding on March 5, 1999 and an Amended and Restated Memorandum of Understanding on March 19, 2010 (collectively "the Agreement") which sets forth the relationship between the two entities; and

Whereas, subsequent to the effective date of that Agreement, the University Board of Visitors on March 20, 2015 adopted its University-Related Foundations Policy, codified as Board of Visitors Policy Number 13; and

Whereas, the relationship between the University and each University-affiliated foundation is expected to conform fully with Board of Visitors Policy Number 13, as it may be amended from time to time ("BOV Policy #13"); and

Whereas, the Foundation and the University wish to express their agreement that the Foundation will comply with and act fully in accordance with BOV Policy #13, then

Therefore, the University and the Foundation agree that the Agreement be supplemented as follows:

- 1. In the event that there is conflict between the Agreement and BOV Policy 13, BOV Policy #13 shall control.
- 2. To the extent that BOV Policy #13 addresses issues or matters not covered in the Agreement, the parties shall be governed by BOV Policy #13.

This Addendum to Agreement shall become effective upon approval by the Board of Visitors of the University and the Board of Trustees of the Foundation, both as evidenced by the signatures below.
