

AREA OF EXPERTIST

My substantive area of research is in child welfare with a particular focus on African-American youth. I have extensive expertise in research within urban communities. I was the co-Investigator of the context matters research project that explored the social, emotional, and environmental correlates of risk among a sample of over 250 youth in public housing. I was also the project director for the District of Columbia Foreclosure and Migration Study (DCFAM), a three- year research project assessing youths' physiological and psychological responses to stress. Additionally, I was a funded research fellow for the Robert Wood Johnson Interdisciplinary Research Leader's program conducting research on violence prevention among youth in Washington DC.

I am currently the principal investigator of the People First Initiative evaluating the relocation of families out of public housing. I am also the principal investigator of the syndemic production of health disparities among Adolescents in public housing in Hampton Roads Eastern Virginia Post-COVID-19 Pandemic, Youth Exposure and Victimization of Community Violence, as well as the community engagement lead on the coastal, and people grant funded by the National Science Foundation.
