BRIEF BIOGRAPHY

Viola Vaughan-Eden, PhD, MSW, MJ, is a Professor at the Ethelyn R. Strong School of Social Work at Norfolk State University, where she served as PhD Program Director for the 2014–2026 academic years. She is President and CEO of UP For Champions, a nonprofit partnered with [The UP Institute](#), a think tank focused on upstream solutions to child abuse prevention. She is also Founder and Principal of [The Vaughan-Eden Collaborative](#), which provides evidence-informed training, research translation, policy consultation, and systems-level strategies to strengthen child and family well-being. A forensic and licensed clinical social worker, Dr. Vaughan-Eden has evaluated or consulted on more than 3,000 child maltreatment cases and qualified as an expert witness more than 700 times. She provides national and international consultation and training on child maltreatment, violence prevention, forensic social work, trauma-informed practice, and multidisciplinary collaboration. Her leadership includes serving as President Emerita and Fellow of the Association of Professionals Solving the Abuse of Children, President Emerita of the National Plan to End Interpersonal Violence Across the Lifespan, and President Emerita of the Forensic Social Work Alliance. She is also the Child Welfare Advisor to the National Family Violence Law Center and a board member of the Beau Biden Foundation for the Protection of Children. Dr. Vaughan-Eden has authored numerous publications including as co-editor-in-chief of the six-volume Handbook of Interpersonal Violence and Abuse Across the Lifespan and co-editor of the APSAC Practice Guidelines on Forensic Interviewing of Children. She has delivered more than 400 hundred presentations to multidisciplinary audiences nationally and internationally, and her honors include multiple lifetime achievement and distinguished alumni awards. The program provides updated, evidence-based practices for identifying, assessing, and responding to CSA, supported by case-based learning, regional guidance, and a comprehensive workbook to strengthen staff skills and confidence.

2023-2024: Louisiana Department of Child and Family Services (LADCFS)

Innovative Solutions for Heroes Protecting Children and Families Impacted by Child Sexual Abuse is a comprehensive two-day training curriculum developed, delivered, and evaluated by The UP Institute

with Stacie LeBlanc, JD, MEd for DCFS Child Welfare staff statewide to include policies, protocols, and practices specific to the nine regional service delivery areas.

2022-2024: Litigation and Evaluation Involving Abuse Allegations in Family Court Cases (LEFCC)

Institute on Violence, Abuse and Trauma (IVAT) Specialty Certification for Family Court Professionals. LEFCC is a grant subsidized innovative specialized 20-hour in-person training for legal professionals (family court lawyers, judges, GALs) and mental health professionals (expert witnesses, child custody evaluators, therapists) sponsored by the Professional Consortium on Abuse Allegations in Family Court.

2022-2023: Victim and Family Advocacy

Victim advocates provide specialized services and resources to ensure consistent, coordinated, and comprehensive support for children and their non-offending caregivers in crisis. This 24-hour training curriculum was developed, delivered, and evaluated by The UP Institute with Stacie LeBlanc, JD, MEd and has been approved by the National Children's Alliance under the 2023 Standards for Accreditation as meeting the requirements for foundational training for Victim Advocates. An additional 15-hour in-person training on advanced victim advocacy was also developed.

2021-2025: Norfolk State University PhD Social Work Program for Asynchronous Online Instruction

Led the development of the online curriculum for the PhD Program in Social Work as well as designing several online doctoral courses. Courses were designed for delivery via Blackboard Learning Management System using Blackboard Learn Ultra in collaboration with the Office of Extended Learning's Instructional Creative Design (ICD) team.

Developed BSW and MSW courses focused on trauma-informed, family-centered social work practice with children and families involved in child welfare or impacted by child maltreatment.
