As part of the School of Business AACSB requirements towards maintaining its AACSB accreditation I have contributed beyond the minimum number of refereed papers set for Sustained Academic Engagement Activities. Overall, my intellectual contributions, over the past five years, can be summarized as follows:

- 6 papers all published in peer-reviewed refereed economic journals.
- I have met the number of peer-reviewed publications needed to maintain my Sustained Academic.
- All 6 papers were accepted for presentations and have been presented at academic or professional meetings.
- All 6 papers are classified in the category of Applied or Integration/Applied Scholarship. With secondary data and hypothesis testing these papers contributed to the body of economic analysis twofold: (1) a better understanding of the theoretical macroeconomic principles underlying the behavior among variables, and (2) predicting the short-run as well as the long-run effects of changes in the macroeconomic determinants on related dependent variables of specific research interest using advanced econometric modelling.

This proposed course for Non-Business Majors was subsequently approved by the School of Business Curriculum Committee, the University Curriculum Committee, and the General Education Council, and it went into effect in the 2022 Fall Semester. BUS 200 examines the knowledge and competencies required for making successful personal financial decisions. It provides a wide range of core financial concepts and techniques including the five-step financial planning process, goal-based financial

planning math, choosing a major and a career, budgeting, paying taxes, time value of money, banking, interest, personal loans, student loans, financial statements, buying a home and mortgage, children and family finance, insurance (health, auto, and home) insurance, saving and alternative investments (including stock market stocks, bonds, etc.), retirement planning, estate planning, starting a business, consumer credit card management, passive income, actively managed income, present value, net worth. Students will be informed how individual choices directly influence occupational goals and future earning potentials.
