and that is the skills and experience matrix that we talked about at the last meeting.

And so, we have that as a, as a guidepost for the, for the needs going forward.

And um, I think we are getting ready to pop it up on screen there.

So. the current lay of the land is if you were not aware, um, but Dr. Jones has submitted her reg, resignation to the board, um, effective April 10th.

11:23

And so, that creates a need for, at a minimum, a replacement for, for her.

11:30

Um, we also have a couple of board members that their terms will be expiring, and the expectation is they would, as long as they're eligible, and they all are eligible, the expectation is that they would be considered for a replacement for another term.

And so, those three individuals or Joan Wilmer, The Honorable Jim Dyke, and um, Dr. Watkins.

11:55

And um, and outside of that,

11:57

so, right now, I think the immediate action for consideration is to make sure that we're all comfortable with the focus of the skillset that we're looking for to replace at a minimum Dr.,

Dr. Jones.

12:12

And so, I had a conversation with, um, one of the folks that is a part of the committee, that makes the recommendations too, um, to the, to the Governor. I had a spoken, meeting with her.

12:27

Um, oh, Bishop is getting a note. He is not able to get in. He's saying, he's that 11 o'clock, so April see if you can connect with him and let him in some kind of way.

12:39

I just get a text.

12:40

He may be trying to come in on the closed portion. Yeah, because the closed starts at 11.

Ah, okay.

12:48

So, he should click on the open, open meeting one.

Got it. Good point, thanks Jim. I'm just texting him.

Um, so, I had a conversation with the, with the individual about the, you know, the timing of, um, a recommendation.

And, so, you know, we're, this is, again, some, some new ground for us as a Committee, and um, supporting the process for recommendations to the committee that will recommend to the Governor. So um, Dr. J, I believe, I guess in the past, and maybe even recently.

I don't know whether or not there have been some discussions with some of the folks, um, in Richmond on your part or anybody that you're aware of. Has there been any, any, any dialog up to this point?

We have not had, as it is my understanding that each, each, cycle, we will have a conversation with myself and Richmond? And, I had one in the last cycle, but I haven't, I have not yet had one cycle.

Very good. Very good.

13:54

So, what I would suggest is that as the committee considers the, you know, the focus that we, we connect, um, and try to land on, um, you know, the particulars. If there's any individuals' that we think would be compelling,

and um, appropriate to be considered that, um,

14:16

we, we collaborate and land on, on that, on that, um, name.

14:22

Otherwise, we can just put forth the criteria to the, um, you know, to the folks in Richmond, so that then they can use that as a guide to help, you know, find the right person.

So, um, so in, on the screen there is the, the recruitment priority, given the current makeup of the Board, and the gaps that we may have. And so, obviously the green, you know are the top priorities, um, are the, you know, the most important things.

But, you know, I think, in my view looking at some of the more, the other areas other than obviously belief in support of the mission.

14:59

Looking at, um, people with maybe some IT background, um, to add to, to the board, because we really don't have, at least, according to this assessment, um, that's probably an area we could use some help in, or even in HR management and administration. So, having a breadth of experiences and backgrounds is always good.

And, if we can, use that criteria to put forth to the, to the folks in Richmond, um, I think that would certainly be, um, be good.

So, I'm going to open up the floor to, to, for discussion. Any thoughts or considerations around this subject?

Mr. Chairman, I, I'd suggest we add government relations as well, especially since Jean Cunningham stepped down from the board.

I think it would be helpful if we had someone who can help us sort of maneuver the, um, intricacies of state and federal government if possible.

An excellent point, Jim, and Ericke, if you'd make note of that on the government relations item instead of it being a two, maybe then that becomes a three, on that matrix given Jim's comment. 16:10
