#### 2. Discussion Items

**Academic and Student Affairs Committee Charter Review** – Ms. Mary Blunt led the following discussion:

- The Academic and Student Affairs Committee Charter was reviewed by the Committee members and staff of the Committee.
- No additions or modifications to the contents of the ASAC Charter were put forward.

Mr. Fulton motioned, seconded by Mr. Henry, the Committee unanimously voted to recommend approval of the Academic and Student Affairs Charter to the Full Board.

**Revisions to the Teaching Faculty Handbook** – Dr. DoVeanna Fulton reported the following:

- The Office of the Provost worked in collaboration and through NSU's shared governance process to revise the Teaching Faculty Handbook.
- Revision of the Handbook is an iterative process and it is anticipated that more revisions will be presented at a future Board meeting.
- Revisions focused on six particular areas: appointment of department chairs, promotion, tenure, academic freedom, the annual review process, and faculty grievance. There were also formatting changes made for consistency and organizational purposes. The following sections were revised:

- Ms. Boston and Dr. Haines were asked by the Committee whether the revisions put forth
  by the Provost and her team have cleaned up the structural issues and other challenges
  brought to the attention of the NSU Board of Visitors. Ms. Boston responded yes and
  added that revising the Teaching Faculty Handbook is an ongoing process. Dr. Haines
  agreed and stated that the faculty have voted on the revised version and are in support of
  it.
- The Committee discussed the proposed accelerated timeline for this year's Promotion and Tenure process with a focus on ensuring advance review for the Committee members and allowing sufficient time for the President's prior approval of the recommendations. Further discussion will take place to schedule the next Committee meeting prior to the full BOV meeting on April 30, 2021.
- The Committee inquired whether Dr. Haines and faculty are in agreement with including a fixed date (April 30) in the Teaching Faculty Handbook for the Provost to send

Promotion and Tenure recommendations and justifications to the President, as well as to applicants. Dr. Haines stated that faculty would like to see required dates included for the President's and the BOV's decisions. However, for this round, this may not be possible. Faculty are comfortable asking for the Provost's decision.

Mr. Fulton motioned, seconded by Mr. Henry, the Committee unanimously voted to recommend approval of the revisions to the Teaching Faculty Handbook to the Full Board as presented.

The continuance of virtual meetings post COVID-19 was discussed. Counsel suggested that the legislative liaison convey the Board's desire to continue virtual meetings to the attention of the Governor and legislators.

#### **Academic Programs Portfolio** – Dr. DoVeanna Fulton reported the following:

- NSU offers twenty-nine undergraduate programs.
- The portfolio of programs presented to the Committee was the top fifteen and the bottom fourteen, which represents a standard reflection of undergraduate institutions across the country.
- The four programs in the bottom fourteen include mathematics, English, history, and physics. These are half of the general education courses, and though the programs have lower numbers of majors, they are extremely essential to undergraduate education.
- The engineering and technology programs often pipeline students into graduate programs.
- The Journalism program was discontinued in the Spring of 2018, but created a Journalism track within the Mass Communications degree.
- Presented two lists of program budgets and profitability for fiscal year 2019. One included the programs with positive operating budgets, and the other included shortfalls.
- The spring 2019 to 2021 Academic Program Enrollment FTE was shared.
- Nursing, Computer Science, Exercise Science, General Business, Psychology and Social Work are the six marquee programs at NSU.

#### **Enrollment Management Strategies** – Dr. Justin Moses reported the following:

• Within the next ten (10) years, enrollments around the country are naturally expected to drop. NSU will do everything it can to maintain and grow enrollment concurrently with its infrastructure needs.

- The recruitment team has been able to continuously meet, and in some instances, exceed target goals, budget goals, and goals set by SCHEV while resource strapped.
- Some of the aggressive recruitment strategies being utilized to target potential students include increasing efforts on recruiting in-state students; recruitment activities with additional out of state markets; collaborating with NSU's School of Graduate Studies and Research to aggressively advertise and market graduate programs at NSU; and integrating virtual tools to engage with students and their families. The upcoming Virtual Open House is just one example of these efforts. Approximately 400 students are expected to participate.
- NSU is utilizing digital marketing, commercials, and other media to provide additional exposure to NSU at the regional and national level.
- External agencies such as Enrollment Fuel are being utilized to support marketing efforts.
- Communications and Marketing is also working strategically with Enrollment Management to showcase the NSU brand and draw potential students.
- NSU is ready to launch the Virtual Tour of the campus, which will allow potential students to experience NSU in a virtual environment.
- The Enrollment Management team has put forth great efforts to virtualize and digitize processes by streamlining application processes, utilizing the National Common Application for admissions, shifting to paperless processes, and creating communications in the CRM system to send information to applicants and current students.
  - Mr. Henry inquired if there was a way to track and document the results/yield of utilizing the Common App platform over the next few years. Dr. Alexander confirmed that this is possible in addition to being able to determine the mechanism a student used to apply.
- Virginia College Affordability Network (VCAN) will allow NSU to provide tuition and help with additional fees for Pell eligible students who live within a 25 mile radius of the campus.
- The Student Planner System will be live by July 1, 2021.
- The use of technology to communicate registration functions/actions will reduce registration errors, allow academic advisors to focus on advising and mentoring students, and aid retention efforts.
- To increase retention, Enrollment Management is working on implementing professional advising for upper division level students, increasing experiential learning, improving student success in barrier courses, expanding online academic programs, and providing collaborative activities for student engagement, mentorship, and professional development.

The Committee inquired about the initiative with Academic Partnerships. Dr. Fulton stated that she does not anticipate students entering the programs until spring 2022. The program will start with a select number of graduate programs and expand over time. Conversations with Academic Partnerships are ongoing. These efforts will take time to include a marketing strategy that will increase NSU's profile for graduate programs for working professionals and adult learners throughout the nation.

#### **Faculty Senate Report** – Dr. Ashley Haines reported the following:

- Faculty are very pleased with the resolution of Promotion and Tenure decisions.
- Faculty Senate standing committees are actively meeting.
- The Faculty Evaluations Policies and Procedures Committee is collaborating with faculty, the Office of the Provost and OIT to identify an online portal for the faculty evaluation process.
- The Enhancing Campus Communication Series initiative has been launched to provide clarity and guidance on interacting with various offices at the university.
- There is a need for training on policies and processes around annual evaluations and various responsibilities of faculty. Faculty are encouraged to provide input.
- Faculty would like to discuss the long-term implications of the Pass/Fail policy for students, especially for programs tied to accreditation.
- Looking to hear from the administration regarding access to COVID-19 vaccinations.
- Guidance is needed on how to proceed with addressing concerns over salary disparities.
- Faculty are hopeful about the idea of shared governance and working together with the administration.

**Student Government Report (SGA)** – Mr. Jeremiah O'Bryant reported that the SGA worked with the Executive Director for Housing and Residence Life to address campus quarantine concerns and worked with Student Affairs and the COVID-19 Taskforce to encourage and provide guidance to students about wearing masks, double masking, and responding to the daily symptom tracker. The SGA also hosted its first "Link Up" event on February 16, 2021. Students had an opportunity to ask questions and share comments and concerns regarding various topics such as the CARES Act and in-person graduation.

Mr. Henry inquired about Career Services and asked if the Committee could receive a report at its next meeting. Dr. Brown responded that this falls under his area, and he will ensure that a report is provided.

## Academic Partnerships—The Road to Implementation

- NSU is collaborating with Academic Partnerships (AP) to enhance academic degree programs offerings online
- Allows accelerated course offerings multiple times a year
- Complete master's degrees in one year
- Provide more flexibility to appeal to adult learners, working professionals, distance learners

- AP provides comprehensive support to NSU systems. They include the following:

  - Program Planning
  - Course Development

  - Course Delivery

# Number of Enrollment Slots

- Six graduate programs will participate in the pilot program, beginning spring semester 2022
- Two of the programs are already offered online, while the remaining 4 programs require the Board's approval for online delivery to be added to the face-to-face offerings
- Online delivery allows for expanded class capacity
- Minimum graduate enrollment required in each program is as follows:

#### **MEAC COMPOSITION**

#### **Projection 2021-22**

- The conference shall sponsor a minimum of six women's and men's sports, one of which shall be in basketball in addition to men's sport football.
- Six (6) is the minimum number needed for the sport to be recognized by NCAA as a conference championship sport.
- Three institutions are leaving the MEAC following the 2020-21 athletic year, reducing membership to eight all-sports members, including six that play football.
- The conference is at the minimum number of members to retain automatic berths into the NCAA championship in a number of sports and has fallen below the minimum number in others (i.e., baseball).

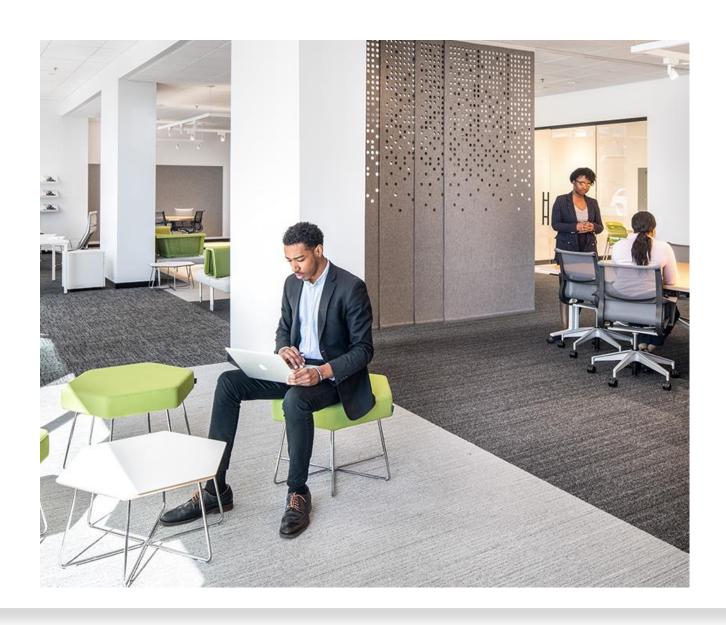
